- *Preference Formation and Elicitation in Valuing Non-Market Goods* (1997-present): This project, based on an NSF grant (R824679), has focused on understanding how individuals make choices about costly public strategies to achieve public goods (e.g., greenhouse gas reductions via carbon

taxes) when faced with substantial complexity and scientific uncertainty. This project has resulted in numerous publications in leading peer-reviewed journals.

- Weather, Climate and Public Policy (2007-present): A group of projects and collaborations with the University of Oklahoma's National Weather Center. This includes participation in the \$75million competition for OU's Cooperative Institute for Mesoscale Meteorological Studies (CIMMS) Center with NOAA. An important part of this collaboration includes studying the societal impacts of weather extremes and climate variability—particularly individual and community response to tornadoes, drought, ice storms, and climate change.
