Training

September 2004 – September 2006, NIMH Post-Doctoral Fellowship

This fellowship is designed as both a research and a training grant. My training has consisted of learning the practice of and culture of psychiatry in both in-patient and outpatient settings. This training involves 3-days-a-week participation in medical rounds in the psychiatry ward of the University of Chicago Hospital as well as once-per-week observation of out-patient chronic schizophrenia patients in the clinic of Dr. Maurice Goldman at the University of Chicago Hospital. My research has been focused on developing a useful methodology for studying the nature of empathy in doctor-patient relations.

October 2004 – November 2004 – SCID Training

This training involved learning how to administer the SCID (Structured Clinical Interview for DSM-IV-TR) psychiatric diagnostic interview – the gold standard for diagnosis. Training was conducted at the University of Chicago.

June 2001 – August 2004, *American Psychoanalytic Association Mentoring Program*This program allowed me to develop an understanding of the professional and clinical practice of psychoanalysts through regular meetings with Dr. Nancy Livingston, a practicing clinical psychiatrist, psychotherapist, and professor in the University of North Carolina – Duke University joint psychoanalytic training program.

During 2006-7, I was involved in developing first phase, long-term research programs for the Romanian equivalent of the National Institute of Mental Health. I worked at the intersection of government (regional, national, and international), public policy, advocacy, and client (patient) groups to develop research projects – including organizing research teams – that will put researchers into the field to consider the qualitative nature of the cultures of clinical settings and the cultural features of the experience of mental illness in Romania. These projects are part of a major reform of the Romanian health system that began in 2006.
